

# Legal Fellow Summer 2024 & Year Long 2024 Remote

## **Position Summary**

As part of our growing Whistleblower Protection Program, The Signals Network (TSN) is seeking a year-long full time Legal Fellow and a Summer 2024 full time Legal Fellow able to serve for a minimum of 10 weeks. The fellows will report to our Legal Director and work directly with our Whistleblower Protection Team to support our growing caseload of work with whistleblowers.

## **About The Signals Network**

Transparency and accountability are the guardrails that keep democracy on track. In many cases, the public relies on courageous whistleblowers for knowledge of government and industry malfeasance. But whistleblowers who come forward often face legal, physical, psychological and economic retaliation.

The Signals Network (TSN) is an international 501(c)(3) organization dedicated to supporting whistleblowers who have shared public interest information with the press and public. Founded in 2017 by journalists, whistleblowers, lawyers and entrepreneurs, TSN operates internationally to hold powerful interests accountable.

To support whistleblowers and hold power to account, The Signals Network has developed an end-to-end approach that includes: **empowering** workers to stand up to power and speak out about wrongdoing; **protecting** whistleblowers who contribute to published reports of wrongdoing; supporting journalists to **investigate** wrongdoing; and, advocating for lasting **change** as a result of whistleblower revelations.

The Signals Network actively supports dozens of whistleblowers globally as they report on wrongdoing and fight for lasting change. These courageous individuals have provided information on the biggest media stories of our time to a range of international media outlets, including Big Tech data violations and government and corporate corruption, #MeToo abuses, political propaganda online, health hazards and more. Their information has appeared in *The New York Times, The Washington Post, The Guardian, Time, Le Monde, BBC, Der Spiegel, The New Yorker* and more. We have coordinated the publication of major investigations through media in the U.S. and across Europe that reached tens of millions of readers. Recently, we provided protections for whistleblowers in Africa as part of a major report in <a href="Imme\_magazine">Time\_magazine</a> on Facebook's content moderation system, in Europe as part of <a href="Uber's">Uber's</a> labor practices and lobbying efforts, and in the US as part of <a href="Twitter's">Twitter's</a> business practices. ## Responsibilities

The Legal Fellow will work with the Legal Director and the Whistleblower Protection Team to help advance the organization's Whistleblower Protection Program. The Fellow will be exposed to all aspects of TSN's work with whistleblowers and thus must be able to operate with the utmost confidentiality and sensitivity.

### The fellow will:

- Conduct legal, factual and policy research at the national, regional and international levels:
- Draft memoranda and briefings to further progress individual cases;
- Undertake case management with respect to individual whistleblowers;
- Field initial requests for whistleblower support through our whistleblower intake system;
- Participate in meetings related to whistleblower support, including with external counsel & partner organizations;
- Draft and edit educational and case-specific advocacy materials for external audiences;
- Support the Whistleblower Protection Team on specific projects aimed at improving the legal environment for whistleblowers and improving public support for whistleblowers themselves;
- Assist in communications aimed at strengthening whistleblower protection, including engaging and training journalists;
- Assist with administrative tasks as required.

### **Qualifications**

### Required

- Year-long Legal Fellow must have a first qualification in law. This can be an LLB, LLM or JD.
- <u>Summer Legal Fellow</u>, at a minimum, must be in the process of obtaining a qualification in law, either an LLB, LLM or JD.
- A key qualification of this role is the ability to work sensitively and with the utmost confidentiality.
- Strong research and writing skills and the ability to work independently are also essential.
- A demonstrable commitment to human rights issues.

#### Desired

- Experience working directly with clients, especially ones who have been traumatized and are vulnerable.
- Exposure to and/or an interest in working with the media and/or policy makers.



# **Salary and Benefits:**

Unpaid. Legal Fellows must have funding to cover the full costs of the fellowship from a university, law firm, professional training program, or other institutional source of funding.

#### Location

Remote work. The team is currently located on the East Coast of U.S. and in Europe and gathers together periodically throughout the year. EST is preferred, but West Coast and other time zones will be considered if the candidate can be flexible in terms of working hours.
