TO THIS END, THE ORGANIZATION SHALL CREATE A MECHANISM TO MAKE THE PROCESS OF EXPOSING INFORMATION THAT BENEFITS THE PUBLIC SAFE FOR THOSE INVOLVED. THE ORGANIZATION WILL WORK WITH ATTORNEYS, PRIVACY EXPERTS, PSYCHOLOGISTS AS WELL AS OTHER EXPERTS TO CREATE A SAFE ENVIRONMENT FOR PRIVATE CITIZENS AND PUBLIC SERVANTS TO EXPOSE WRONGDOING. THE ORGANIZATION WILL ALSO WORK WITH MEDIA ORGANIZATION INVOLVED INVESTIGATIVE JOURNALISM TO SUPPORT.
